FEDERAL GOVERNMENT'S "30 x 30" LAND PRESERVATION GOAL: Moved-Seconded (Ewing-Rosenau) to approve and adopt the following Resolution #2021-17 A RESOLUTION OPPOSING THE FEDERAL GOVERNMENT'S "30 x 30" LAND PRESERVATION GOAL. Motion Carried. LAWRENCE COUNTY RESOLUTION #2021-17 A RESOLUTION OPPOSING THE FEDERAL GOVERNMENT'S "30 x 30" LAND PRESERVATION GOAL WHEREAS, Lawrence County is a political subdivision of the State of South Dakota; and WHEREAS, Lawrence County containing about 511,938 acres of land is situated in the State of South Dakota; and WHEREAS, the federal government owns 54% of the land within the County, and the United States Forest Service and Bureau of Land Management are responsible for managing over 279,159 acres of these federal lands; and WHEREAS, the Black Hills National Forest comprises 274,000 acres of land and the BLM comprises 4,708 acres within Lawrence County; and WHEREAS, designating lands as wilderness does not assure its preservation. Left in an undisturbed or natural state, these lands are highly susceptible to wildland wildfires, insect infestation and disease, all of which degrades the natural and human environment; and WHEREAS, the well-being, health, safety, welfare, economic condition, and culture of the County, its businesses, and its citizens depend on private land ownership and the use of these resources; and WHEREAS, many of Lawrence County's businesses and its citizens are involved in or otherwise depend on industries that utilize private lands and their resources, including the forest

products industry, livestock grazing, mining and mineral development, recreational industries, hunting and other outdoor recreation; and WHEREAS, these industries are important components of the South Dakota economy, and are major contributors to the economic and social wellbeing of Lawrence County and its citizens; and WHEREAS, on January 27, 2021, President Joseph R. Biden, Jr., issued Executive Order 14008 entitled Tackling the Climate Crisis at Home and Aboard (86 Fed. Reg. 7,619); and WHEREAS, in Section 216 of Executive Order 14008, President Biden directed the Secretary of the Interior, in consultation with the Secretary of Agriculture and other senior officials, to develop a program to conserve at least 30 percent of the lands and waters in the United States by 2030, which is called the "30 x 30" program; and WHEREAS under the 30 x 30 program, some 680 million acres of our Nation's lands would be set aside and permanently preserved in its natural state, preventing the productive use of these lands and their resources; and WHEREAS, there is no constitutional or statutory authority for the President, the Department of the Interior, the Department of Agriculture, or any other federal agency to set aside and permanently preserve 30 percent of all land and water in the United States, and no such authority is referenced in Executive Order 14008; and WHEREAS, placing private lands into permanent conservation status will cause dramatic and irreversible harm to the economies of many states, including South Dakota, and in particular rural counties such as Lawrence County whose citizens depend on private lands for their livelihoods; and WHEREAS, the 30 x 30 program, if implemented, will conflict with the plans, policies and programs of Lawrence County; and WHEREAS, Executive Order 14008 at 216(a) directs the Secretary of the Interior, in consultation with other relevant federal agencies to "submit a report to the Task Force within 90 days of the date of this order recommending steps that the United States should take, working with State, local, Tribal, and territorial governments, agricultural and forest landowners, fishermen, and other key stakeholders, to achieve the goal of conserving at least 30 percent of our lands and waters by 2030." NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lawrence County, South Dakota, as follows: 1. The Board opposes the 30 x 30 program, including its objective of permanently preserving 30 percent of the Nation's lands in its natural state by 2030, or any similar program that will set aside and prevent the productive use of millions of acres of our lands. 2. The Board further opposes the designation of lands in Lawrence County as wilderness, wilderness study areas, wildlife preserves, open space, or other conservation land, thereby restricting public access to such lands and preventing the development and productive use of the resources on or within such lands. 3. The Board supports the continued private ownership of land in the County, recognizing the Nation's need for domestic sources of minerals, energy, timber, food, and fiber. 4. The Board recognizes and supports the State of South Dakota's water rights system, and other state laws and programs governing water rights and water use, and opposes any federal designation of waters and watercourses within the County that would impair or restrict water diversions and uses authorized under South Dakota law. 5. The Board supports reasonable national, regional, and global greenhouse gas emissions policies and goals that are comprehensive, practical, cost-effective, and do not unnecessarily single out specific industries or activities, but opposes the use of global climate change as an excuse to set aside large tracts of land as preserves or open space to fulfill the 30 x 30 program's objectives. 6. The Board also maintains that any lands or other rights that are acquired to fulfill the 30 x 30 program's objectives should be acquired only from willing landowners and for the payment full and fair market value for all rights and interests acquired, and not through regulatory compulsion, and only after analyzing and considering the impacts of such land acquisitions on the well-being, health, safety, welfare, economy, and culture of Lawrence County, its businesses, and its citizens. 7. The Board shall send a copy of this Resolution to the Department of Interior and all other relevant Federal and State agencies; and Duly passed and adopted at a regular meeting of the Lawrence County Commission on the 27th day of April, 2021. MOLLER ROAD: Randy Sachau, 20023 Ashlee Ct, was present to discuss the maintenance of Moller Road and the new sub-division Cedar Berry Canyon Estates. Sachau added that the residents of Cedar Berry Canyon Estates, Crow Peak Bench and Wild Turkey Estates use Moller Road as an access road which will now service over 60 lots. Sachau stated that as of right now there is no maintenance arrangement on Moller Road.

Eric Neis, Attorney for Cedar Berry Canyon Estates and Trent Walters, Interstate Engineering, were present to address questions on behalf of Cedar Berry Canyon Estates.

Allan Bonnema, Highway Superintendent, stated that Moller Road is on the state map as a county secondary road. Bonnema offered an estimate of what it would cost the county to update Moller Road from Crow Peak Bench Road to Gobbler Road.

EXTENSION UPDATE:

Michelle May, Butte/Lawrence County Extension was present to give an update on the 4-H Youth Program.

<u>PUBLIC SAFETY AND SERVICES CENTER PROGRAMMING PRESENTATION:</u> Tony Vie and Joshua Kasper, Elevatus Architecture, and Brian Dean, Sheriff, presented the Lawrence County Public Safety & Services Center programming & conceptual design. A copy of the presentation is available for review in the Lawrence County Auditor's Office and posted on the Lawrence County website.

Vie and Dean reminded the Commission that Elevatus Architecture completed a study on the current jail facility that resulted in a recommendation to build a new facility. The cost of adding on to and renovating the current jail would likely cost more than a new facility.

In October 2020 Elevatus started working with Lawrence County representatives to create a "Programming and Conceptual Design" package for the Lawrence County Public Safety and Services Center. They explained that the presentation reflects the conceptual solutions developed to meet the County's needs for the project.

Both Vie and Dean emphasized that the design concepts and cost estimates reflected in the presentation are preliminary in nature and are subject to change as the project is more fully developed and refined.

Dean stated the next step in the process is schematic design and to enter into an agreement with Elevatus Architecture for that purpose. Commissioner Rosenau and Deibert will step down from the programming committee to allow for two other Commissioners to be involved on the schematic committee.

Moved-Seconded (Flanagan-Deibert) to appoint Daryl Johnson, member from the public, Commissioner Richard Sleep and Commissioner Robert Ewing to the Public Safety and Services Center schematic design committee. Motion Carried.

<u>COURTHOUSE ROOF AND MASONRY PROJECT:</u> Bruce Outka, Deputy State's Attorney, and Steve Williams, Williams & Associates, gave an update on the Courthouse Roof and Masonry Project. Outka stated that two quotes have been received but not in time to allow for review prior to the meeting.
